Chapter Structure & Finances

IDA-MA maintains, through IDA Headquarters, LLC status in the Commonwealth of Massachusetts. It has established a checking account for handling incidental income and expenses, though at present IDA-MA is not soliciting chapter memberships distinct from IDA itself. A financial report for 2019 is attached as Appendix A

Chapter Membership

As of September 4, 2019, IDA had 165 active members in Massachusetts. All of these individuals are considered members of IDA-MA, whose officers occasionally send out emails to the entire list. Separately, we maintain a list-serv via Google Groups, which currently has 84 members, 15 of whom joined during 2019.

Although Massachusetts is a relatively small state, it has geographical "divisions" that do not routinely interact. So we have established ties with light-pollution activists with good geographical separation: Greater Boston, MetroWest Boston, North Shore, South Shore, western Massachusetts, and Cape Cod.

The chapter holds a monthly meeting via teleconferencing that is announced and open to all members of the Google Groups list.

IDA-MA Annual Meeting

Our second annual meeting, on September 7, 2019, drew roughly 25 chapter members from around the state. Held at the Boston headquarters of the Appalachian Mountain Club, it featured an especially strong set of speakers:

- John Judge, Executive Director, Appalachian Mountain Club
- Dr. Chuck Czeisler, Baldino Professor of Sleep Medicine, Harvard Medical School

James Lowenthal, IDA-MA's President, detailed the chapter's recent activities and future plans. Afterward, officers met with Ruskin Hartley to discuss chapter activities and relevant topics.

Key Activities in 2019

Statewide legislation

Our major initiative in 2019 was advocating for statewide legislation co-authored by IDA-MA members Glenn Heinmiller, Kelly Beatty, and Mario Motta. If enacted, this bill will create the first statewide 3000K CCT maximum for state and municipal exterior-lighting installations. It would also require the Dept. of Public Utilities to establish rate tariffs for low-wattage streetlights and those with wireless-network control. Finally, it requires the Department of Transportation to adopt best practices for roadway lighting and to employ passive safety and wayfinding measures where appropriate.

Identical versions were submitted in the House and Senate, with a total of 26 co-sponsors; full text of the bill is available at https://malegislature.gov/Bills/191/S1937.

At a public hearing on May 30, 2019, James Lowenthal, Timothy Brothers, Leo Smith, and Kelly Beatty presented testimony to the Joint Committee on Telecommunications, Utilities, and Energy. Since then, both IDA-MA officers and members have advocated strongly for the bills' passage.



We await the bills' transfer to Ways and Means Committee for further consideration.

Stakeholder Engagement in 2019

IDA-MA made significant progress in engaging outdoor-lighting stakeholders. Most significantly, chapter officers partnered with the Massachusetts Municipal Association (mma.org), which represents municipal governments for the state's 351 cities and towns, to create "best practice" policies that have been distributed to MMA's membership; see https://is.gd/XVO5G9. We have also forged close collaborations with the national office of the Appalachian Mountain Club and the Massachusetts chapter of the Sierra Club.

Individual IDA-MA members made dozens of presentations to various community groups and officials throughout the year. See Appendix B for a complete list.

Membership Growth in 2020

IDA-MA awaits detailed structure for coordination of memberships and annual dues among IDA and its various chapters. In the meantime, IDA-MA will continue to promote IDA membership at presentations by its members and through its contacts with local stakeholders.

Strategic Plan for 2020

IDA-MA's officers are working on a strategic plan for 2020 that aligns with IDA's organization-wide plan. Specific goals will include:

- passage of statewide lighting legislation
- aggressive engagement of local stakeholders (e.g. MMA, MAPC, Sierra Club, AMC, Audubon, IES-MA)
- creation of a robust website (to replace https://idamass.wordpress.com/)
- establishment of fundraising activities that cover LLC costs and benefit IDA-MA initiatives
- coordinated involvement with municipalities to develop outdoor-lighting bylaws/ordinances
- scheduling of public events to showcase the night sky and create light-pollution awareness
- coordination of statewide effort to collect meaningful sky-quality measurements
